Expression of Interest Opportunity

- <u>Purpose.</u> The purpose of this document is to provide information about the No Place Like Home (NPLH) program through Riverside University Health System – Behavioral Health (RUHS-BH) and to provide an opportunity for parties to express their interest in being a co-applicant with RUHS-BH for NPLH funds by completing the attached Expression of Interest Form.
- 2. Background. The NPLH program was established by the California legislature to dedicate up to \$2 billion in bond proceeds to be used to acquire, construct, and/or rehabilitate permanent supportive housing for persons who are in need of mental health services and are experiencing homelessness, chronic homelessness, or who are at risk of chronic homelessness. Applications can be submitted by counties solely or with a housing development sponsor as a co-applicant. RUHS-BH will submit applications for Riverside County with a housing development sponsor as a coapplicant. The housing must utilize low barrier tenant selection practices that prioritize vulnerable populations and offer flexible, voluntary, and individualized supportive services. RUHS-BH will commit to providing mental health services and helping to coordinate access to other community-based supportive services for eligible residents. Information about the RUHS-BH NPLH program can be found at rcdmh.org/Administration/NPLH. The NPLH program is administered by the California Department of Housing and Community Development (HCD). - 3. <u>Upcoming funding opportunity.</u> Opportunities to apply for funding under the NPLH program will be announced from time to time by HCD. The first round of competitive funding was announced in August 2018. Applications were due in January 2019 and funding awards were announced in June 2019. The second round of competitive funding was announced in September 2019 for a pool of approximately \$ 80.8 million in funding. Applications were due to HCD in January 2020. Award announcements are expected to be made by HCD in June 2020.
