- 2. Identify stages of trans identity development and related assessment issues.
- 3. Increase awareness of transgender clinical needs and identify related interventions.
- 4. Understand the basic tenants of Affirmative Psychotherapy with trans consumers and their families.

Learning Objectives:

- 1. Participants will be able to name the six (6) transgender identify development stages as theorized by Lev.
- 2. Participants will be able to understand gender dysphoria as a clinical standard in the DSM 5.
- 3. Participants will be able to identify the four (4) components of Meyer's Theory of Minority Stress.
- 4. Participants will evaluate the statistics regarding the consequences of rejection as experienced by LGBT youth.
- 5. Participants will be able to identify the four (4) stages of Family Emergence.
- 6. Participants will be able to explain trans identity and trans experience as it relates to care planning.
