## Co-Occurring Disorders 101 October 11, 2023 9:00am-12:15pm

**Course Description:** Substance use disorders (SUDs) affect many aspects of a person's life including their mental health, physical health, social relationships, vocational endeavors, and more. This training will provide background information on the consequences of substances commonly used by consumers and will introduce participants to the epidemiology and neurobiology of co-occurring disorders. Participants will learn how to conceptualize co-occurring mental health, substance use, and physical health disorders and how their interaction affects screening, assessment, and treatment. Participants will also learn how to develop behavioral intervention strategies for those with co-occurring substance use, mental health, and chronic medical conditions that frequently co-occur. The training will also cover treatment considerations including an overview of evidence-based practices for CODs, including Motivational Interviewing, Cognitive Behavioral Therapy, and integrated behavioral health interventions.
